

wire China 2022 in November to take place in Nanjing once

Against the background of sustained pandemic-control measures in partial regions of China, the organisers of wire China have decided to postpone the trade fair originally scheduled to take place at the Shanghai New International Expo Center in September. Current developments in the pandemic situation do not permit reliable planning and holding of trade fairs in Shanghai over the next few months.

In Nanjing, three hours away from Shanghai by car, the situation is different. Here control measures have been relaxed and major events such as trade fairs can be held subject to comprehensive hygiene measures. This is why wire China will be held there once. Nanjing is the capital of Jiangsu, a province on the East coast of China, and located about 300 km from Shanghai. During the Ming Dynasty this city occasionally served as capital of the country.

This is why wire China as the leading regional trade fair for the Chinese wire and cable industries will present its innovations for the first time at the Nanjing International Expo Center from 8 to 11 November. Concurrently three expert conferences with a different focus will complement the ranges on display: the Wire & Cable Industry Conference, China Wire & Cable Material Conference and China Winding Wire Conference will be held in parallel.

The visitor registration system will remain live until early November at www.wirechina.net; visitors who have already registered for wire China 2022, will keep their former registration codes and can collect their admission tickets on site.
